President's Award

Dr. Ruth K. Finkelstein

Executive Director, Brookdale Center for Healthy Aging,
Hunter College, CUNY

The President's Award recognizes a leader in the field for his/her outstanding service. This year's Award is presented to Dr. Ruth Finkelstein, ScD.



Ruth is the Executive Director of the Brookdale Center for Healthy Aging at Hunter College and a professor in both Public Health and Public Policy. She leads CUNY's aging research and policy center, devoted to making it possible for everyone to age as well as anyone can.

Ruth has directed award-winning aging initiatives, including the Age Smart Employer Awards, promoting the success of employers of multigenerational workforces; Exceeding Expectations, a digital narrative following New Yorkers over 80; and Age-Friendly New York City, winner of the "Best Age Friendly Initiative in the World" prize. She has won individual recognition, including the 2019 Maggie Kuhn Award, Next Avenue's "Influencer in Aging" in 2016, City and State's "Outstanding Women" in 2020, and Metropolis Magazine's "Game Changer" in 2012. She has advised more than 50 NGO and government entities around the world on adopting an "age in everything" approach to planning.

Before transitioning to aging, Ruth conducted policy-relevant HIV research, with particular focus on drug users and medication adherence. She has a doctorate in health policy from the Johns Hopkins school of public health, an MA in medical anthropology from Case Western Reserve, and a BA from the University of Michigan.

The purpose of the Walter M. Beattie Jr. award is to honor a distinguished member of SSA for outstanding contributions to the work of SSA and for commitment to the goals of the State Society. This year's Award is presented to Dr. Tom Caprio.



Dr. Thomas Caprio is a geriatrician and Professor of Medicine, Psychiatry, Dentistry, Clinical Nursing, and Public Health Sciences at the University of Rochester Medical Center (URMC). He serves in multiple leadership roles at URMC including the Chief Medical Officer for UR Medicine Home Care, Hospice Medical Director, Director of the Finger Lakes Geriatric Education Center, and medical director of the UR Geriatric Assessment Clinic.

He is the Past-President of the National Association of Geriatric Education Centers, Past-President of the National Association for Geriatric Education, as well as the Past-President of the State Society on Aging of New York. Dr. Caprio received his medical degree from the State University of New York at Buffalo, completed residency, fellowship, and post-doctoral studies at the University of Rochester, and earned both a Master's of Public Health and a Master's in Health Professions Education from the University of Rochester. He is a fellow of the American College of Physicians, Fellow of the American Geriatrics Society, Fellow of the American Academy of Hospice and Palliative Medicine, and Fellow of the Gerontological Society of America.

Advocate for Older Adults Award

Laura Whitehorn

Co-founder, Release Aging People in Prison (RAPP)

The Advocate for Older Adults Award recognizes a record of planning, policy development, and advocacy work. This year's award is presented to Laura Whitehorn.

Laura Whitehorn (she/her) has been active in social justice movements since the 1960s. She spent 14 years in federal prison, where she saw the ways in which women of color and their families are harmed by long and life sentences. In prison she founded and took part in HIV/AIDS education and counseling. After her 1999 release, she worked for ten years as a senior editor at POZ Magazine. She helped create and edit "Turn It Up: Staying Strong Inside," a free health and wellness magazine by and for incarcerated people.



Whitehorn has contributed essays and artwork to numerous collections and anthologies. She edited "The War Before," a collection of writings by the late Black Panther organizer and political prisoner, Safiya Bukhari, and helped organize "Self-Determination Inside/Out," an exhibit at the Interference Archive in Brooklyn on how the struggles of incarcerated people from the Attica rebellion to the present have affected social movements. With her late formerly incarcerated partners, Mujahid Farid and Kathy Boudin, and with the advocate and attorney, Soffiyah Elijah, in 2013, Whitehorn co-founded Release Aging People in Prison (RAPPCampaign.com). RAPP, which is led by formerly incarcerated people and family members, was the first organization in the country to advocate for the release of older people amid an ongoing crisis of aging in prison.
